CenterPoint Energy Low Income Rental Efficiency Program
Landlord Application**

Dear Property Owner:

Thank you for your interest in CenterPoint Energy’s (CPE) Low Income Rental Efficiency Program, an energy conservation program for property owners renting to **income-eligible tenants**. CPE provides funding for the services and the program is administered by the Energy CENTS Coalition (ECC). ECC has administered energy conservation services for both Xcel Energy and CPE for over a decade.

The program offers a **FREE, no obligation** energy audit. An energy auditor will make recommendations about insulation levels and furnace, boiler, or water heater replacements. To participate in this program, landlords are required to contribute 50% of all costs for any additional insulation or energy-efficient HVAC equipment. All units must be occupied! Average, estimated costs are listed below. Please keep in mind that these are just estimates and that your property may not need all of the listed measures.

Funds for this program are very limited and services are offered on a first-come/first-serve basis.

To qualify for the program, at least half of the tenants residing in each of your properties must meet the following income guidelines. **Proof of tenant income is required** *unless* tenants received a grant from the Energy Assistance Program within the last two years.

Please see the information below for the tenant income-eligibility guidelines.

If your property qualifies for these services (tenants are low-income), the next steps include:

- 1) Returning the tenant applications. **All** tenants in each property **MUST** complete the enclosed applications (we must have their permission to obtain natural gas usage information from CenterPoint). Each tenant must provide CenterPoint Energy AND Xcel Energy Account Numbers. Tenants must provide income information. If they have not received Energy Assistance, tenants must also provide proof of income (tax returns, paycheck stubs, public assistance award letters, etc.). The tenant must sign the form.
- 2) Once we receive all completed applications, we will determine if the gas usage is high enough to warrant an energy audit (**this usually takes two to three weeks**).
- 3) Staff from the Center for Energy and Environment will contact you to schedule your free energy audit.
- 4) We will provide you with a list of the auditor's recommended energy improvements and send you an agreement for your contribution (50%) to all agreed upon conservation measures (**this usually takes two weeks after the audit is complete**).
- 5) Once we receive your contribution for the HVAC and insulation measures, both contractors will contact you directly (HVAC work will be done first) to schedule the work.
- 6) After the work is completed, staff from the Center for Energy and Environment will contact you to schedule a post-inspection to ensure the quality of the work that was performed.
